

## **2010 MONROE COUNTY FALL FESTIVAL SEPTEMBER 16-18**

The 2010 Monroe County Fall Festival will be September 16-18, 2010. The festival will be in the same area as last year, around Marci Lewis Park. The road will be blocked off from the old fire station to the ball fields. Craft booths will be located in a grassy area with some shade. **All items for sale must be made by the artisan who is exhibiting and renting the space.** The fee for a 10' X 12" space is \$50.00. You may rent more than one space. Hours for the craft booths will be 5:00 p.m. to 10:30 p.m. on Thursday, Noon to 10:30 p.m. on Friday, and 9:00 a.m. to 10:30 p.m. on Saturday. You may open earlier on Friday if you wish. School children and senior citizens attend programs on Friday morning. The deadline for registration is September 1, 2010 and the fee is non-refundable after that date. For more information please see the enclosed list of rules.

If you are interested in participating, please fill out the attached application and return it to us with a check for the total fee. Craft vendors new to the Fall Festival must enclose two or three photos of their craft. The festival committee always provides a large variety of programs and exhibits for the festival, including a large parade on Saturday afternoon. We are proud of the quality of items that have been for sale in the past and hope you will give consideration to reserving a space!!

## 2010 Monroe County Fall Festival Rules

Trailers are permitted if it is a sales unit not a storage or camping trailer. No RV's will be allowed. You must rent a space large enough for the trailer and the hitch and be available to set it in place by noon on Thursday. Please let us know on the application if you will be using a trailer in your display.

The Monroe County Fall Festival Association will provide 24-hour police protection; the Association will not be responsible for anything damaged because of theft, vandalism or weather. Each exhibitor will make the decision about whether or not he or she will set up and tear down each day. Set up times will be provided later. Tear down must be done on Saturday evening so the clean-up crews can begin as soon as possible.

The Festival Association will provide lighting for the evening hours. However, exhibitors will need to provide any lighting for their area. An outlet will be available, but you must provide an extension cord along with your lights. There is no fee for this electricity. Extra appliances use a lot of electricity. If you will be using electricity for more than lights, please indicate that on your application. **NO ELECTRIC HEATERS, COFFEEPOTS OR CROCK-POTS!!!**

You will need to provide your own set-up (tables, display, tent, etc). These do not need to be taken down each evening, unless you want to do so. As stated above the Monroe County Fall Festival Association is not responsible for anything damaged.

Each participant will be issued a space number upon receipt of entry fee and acceptance to show. This information will be mailed to exhibitors the first week of September. Each space is 10 feet deep by 12 feet wide.

The entry fee is \$50.00 for all three days. The deadline for entry fee and application is September 1, 2010. The fee is non-refundable after September 1, 2010. There is no rain date. The show will go on regardless of weather.

**All participants must agree to stay open for the duration of the show and to be open for sale during all of the hours stated below:**

**Set-up hours are 8:00 a.m. to 3:00 p.m. Thursday**

**Thursday 5:00 p.m. – 10:30 p.m.**

**Friday Noon – 10:-30 p.m.**

**Saturday 9:00 a.m. – 10:30 p.m.**

**No vehicles will be allowed on the festival grounds before closing Saturday night.**

The craft show is a juried show. If you have not displayed items with us before, please send 2-3 photos of your work to determine eligibility. The photos must accompany your application.

**All items for sale must be made by the person renting the booth.** The Festival Association reserves the right to make decisions based on definitions of what constitutes art, crafts, assign spaces, and to refuse exhibition of unsuitable materials. We reserve the right to ask you to remove articles that we feel do not meet our Craft Show requirements. Acceptance is up to the discretion of the Festival Association.
